1 Introduction

1.1 Overview

The CAQH Provider Data Portal is the premier industry solution for dentists to easily self-report data required by dental plans other organizations. This information is used for credentialing, directory management, claims, and other key functions.

The American Dental Association (ADA) and CAQH are working together to make it easier for dentists to enter and share their professional and practice data with dental plans and other healthcare organizations by utilizing the CAQH Provider Data Portal. Dentists can enter their professional and practice information one time and submit it to the participating dental plans and organizations of their choice, reducing the administrative burden of the credentialing process. This data can also be used to update provider directories and other business needs.

This service works by allowing any US Licensed Dentist to access their CAQH Provider Data Portal profile by first logging into their My ADA profile on ADA.org/godigital. After logging into My ADA, and accepting the terms and conditions, dentists will be redirected to the CAQH Provider Data Portal Welcome Page. There, they may see certain prepopulated information from the ADA - or the information they attested to previously - making it easier and quicker for dentists to complete and attest to their CAQH profile.

NOTE: Any U.S. licensed dentist can use the ADA credentialing service, free of charge, regardless of their ADA membership status. Visit ADA.org/godigital to start the process. 2 Using the Provider Data Portal


All U.S. licensed dentists, including ADA members and non-members alike, will begin at the ADA online portal in order to access the Provider Data Portal. Perform the following steps to complete your CAQH Provider Data Portal profile:

Navigate to https://www.ada.org/godigital and then enter your login credentials. Your nine-digit ADA number is used for your User ID. A self-service password reset feature is available if needed.

NOTE: If you need help retrieving your ADA number or resetting your ADA password, please contact the ADA Member Service Center at 800-621-8099 or <u>msc@ada.org</u> (Monday – Friday 7:00 AM – 6:30 PM Central Time).


2. Click the **Log In** button. You will be directed to navigate to your My ADA Account.

Please note that located near the bottom of the ADA login page, there is an option for non-dentists to create an ADA account. This is not an option to gain access to the ADA credentialing service or to submit credentials on behalf of a dentist. Access to the ADA credentialing service is limited to dentists and currently enrolled dental students only. The dentist must be logged in to their own ADA account in order to access the ADA credentialing service.




Graphic 1: ADA Login Page

- 3. Complete the fields to self-register.
- If you attempt to self-register in the Provider Data Portal, the Sign In page will request that you register on the ADA site. If you try to create a new CAQH profile, the system will prompt you with the error message below. The system will not allow you to proceed with registration and the Continue button is disabled.

- · Familiarize yourself with the type of information that the profile will require.
- Familiarize yourself with the required steps to complete your profile.
- · Have the proper materials available for reference when you start.
- If your practice has administrative staff that manages information for multiple providers, data entry will be
 easier.
- Please note: Data that is the same for multiple providers (e.g., clinic name, address and phone number) can be
 entered once, rather than entering repeatedly for each individual provider.





4. Once you have successfully logged in to your My ADA profile, the ADA credentialing service Terms and Conditions are displayed. Click the checkbox to acknowledge that you've read, understand, and agree to the Terms and Condition and then click the Get Started button.



Graphic 4: Terms and Conditions


5. The CAQH Provider Data Portal landing page is displayed. Click the **Get Started** button.

6. You will be directed to the Personal Information page. Please note that for new users, select information that you entered in your My ADA page may be transferred to your Provider Data Portal profile. You do not have to re-enter this information but confirm that it is correct and if not, please update as needed.

You must complete all required fields, upload all required supporting documents, and review the accuracy of your information before completing your profile. You must also authorize the organizations you choose to receive your data. The ADA and CAQH both recommend all dentists choose the global setting to increase administrative efficiency. Once data entry is complete for the profile, you must attest to your information.
